The investment objective of the Fund is to provide a long-term total return above that of the UK consumer price index. The Fund will be actively managed and invest in multiple asset classes with a portfolio of transferable securities which may include investment trusts, collective investment schemes, deposits, money market instruments, derivatives and other alternative investments such as structured products, commodity and property funds. The investment manager has the discretion to weight the portfolio towards any investment type, or geographical region, at any time provided it is compatible with the investment objective, risk parameters and policy of the Fund as a whole.







Portfolio activity and comment

Thanks to a buoyant US economy, an accommodative Federal Reserve and signs of progress with the US/China trade talks, the US S&P500 index enjoyed a good month, rising 3.8% in April. Consequently, global stocks gained although the stronger US dollar appeared to hold back emerging markets, impacting those countries with US dollar debt. However, the dollar strength against most currencies was beneficial for the UK's exporters who make up most of the FTSE100, which rose 2.5%, despite little change against Sterling. Markets also took a favourable view of surprisingly good US corporate earnings as the reporting season came to a close. Unemployment levels were unchanged but still at a very low level of 3.8% and, combined with rising wages, further supported cyclical stocks into month end. In the Eurozone, the ECB kept interest rates on hold, as expected, with manufacturing data remaining weak. The positive performance of the UK's FTSE 100 index masked some deep concerns over the delaying of Brexit until 31st October although some relief was evident that "no deal" had been avoided despite the prospect of the UK possibly having to hold European elections in the event there is no resolution by 23rd May. Remarkably, the UK economy held up well in the first quarter of 2019 despite the effect the continued uncertainty must be having on UK businesses and consumers. Retail sales rose, underpinned by solid employment figures and a rise in real wages. With markets pushing up at month-end, the fund finished up 2.28%.
