### **Investment Objective**

The investment objective of the Fund is to provide a long-term total return above that of the UK consumer price index. The Fund will be actively managed and invest in multiple asset classes with a portfolio of transferable securities which may include investment trusts, collective investment schemes, deposits, money market instruments, commodity and property funds. The investment manager has the discretion to weight the portfolio towards any investment type, or geographical region, at any time provided it is compatible with the investment objective, risk parameters and policy of the Fund as a whole.



## Portfolio activity and comment

The current climate of falling markets has raised regulatory concerns over "less liquid" investments and this has manifested itself into a requirement to apply a valuation, or price, to assets as if one had to sell them today regardless of demand. Otherwise known as "Fair Value Pricing" this procedure pays scant attention to the long-term viability and credibility of the predicted return of the investment. External factors caused by the climate we find ourselves in has forced a large write down to one of our holdings, Carpe Valorem, to 31.24p in the pound based on the lowest prices achieved in recent underlying investments by Carpe Valorum themselves. We believe this to be an unreasonable assessment of the true value of the investment over the longer-term. Furthermore, the investment is now suspended and in a state of winding up. The assets will now be sold or redeemed over a shorter time span than originally anticipated. The effect of winding down Carpe Valorem has had a material impact on the value of the two FACET funds. While this is being resolved, our ACD WAY Fund Managers have taken the decision to temporarily suspend investments into, or redemptions from the funds. As managers of the fund, we will do everything we can to realise the best price possible for this single asset and when we are sure what the return will be. The FACET Balanced Fund rose 0.85% in November.

Christian has been regularly featured in the media with appearances on TV and radio.

Alex's expertise in volatility analysis and technical analysis underpins the investment approach of the fund.
